On all credit card transactions over £ 5,000, a 1.5% charge may be made to cover charges from the credit card provider.

Your credit card issuer might treat deposits placed by your card as a 'Cash Advance' (and charge you according to their tariffs). Unfortunately Tradefair is not privy to this information and will not be able to tell if this is the case.

In accordance with our 'Anti-Money Laundering' procedures, we will refund/remit funds back to the card of source. In some circumstances, this may not be possible and as an alternative we will pay/remit funds to the bank account nominated on your funds request form.

- Cheques drawn on an overseas clearing bank may take 4 to 6 weeks to clear (from time of deposit).
- Tradefair may not make or receive any payment via a third party.

Before depositing funds, please be aware that Tradefair cannot accept third party deposits where the name on the bank account and the name on the Tradefair trading account differ.

We do not accept cash or the following cash equivalents:

- Cashier's cheques
- Money orders
- Traveller's Cheques
- Bank Drafts
- Funds from money transfer services

**Wire Transfer Conversion Fees:** The conversion rate will be the current Tradefair Ask (Buy) rate plus a conversion premium of up to 3%. This premium covers the cost of purchasing small and uneven amounts of physical currency from other parties. Incurring this premium will reduce the net amount of funds deposited.
