In consideration of Global Forex Trading, Division of Global Futures & Forex, Ltd., acting for and on behalf of Global Futures & Forex, Ltd. ("Tradefair Financials"), licensing the output of Foresight A.I. (the "Service") to Customer pursuant to the terms of this Agreement, Customer agrees and acknowledges as follows:

1. Tradefair Financials hereby grants to Customer a limited, non-exclusive, non-transferable license to use the Service for Customer's personal trading only. This license does not convey to Customer any interest in or to the Service, but only a limited right of use revocable by the terms of this Agreement. The Service shall be utilized by Customer only in accordance with this Agreement and shall not be disclosed in any form by any media to any other person or party.

2. Subscription Fee and Term. Subscriber will prepay Tradefair Financials its published subscription fee for the license and access to the Product. The term of the license shall be the period of time for which Subscriber has prepaid the subscription fee charged by Tradefair Financials for the Product. Any subscription fee paid is nonrefundable. The license and access shall immediately terminate if a required fee is not paid when due. The Subscriber will be charged immediately for the first month, and if the Subscription starts on a date other than the first date of a calendar month, the amount due for the first partial month will be pro-rated. Thereafter Tradefair Financials will charge the Subscriber on the 25th of each month for the following calendar month's subscription. If the Subscriber wishes to cancel the subscription, he/she will do so effective the first day of a calendar month by notifying Tradefair Financials of the cancellation by e-mail or certified mail by the 20th of the previous calendar month. No refunds will be made for payments previously made if a subscription is cancelled by the Subscriber before the end of the month.

3. Customer represents and warrants that Customer is not a broker or professional money manager, and will not use the Service for trading by or for the benefit of any other person.

4. Customer will be responsible for maintaining all equipment used by Customer in connection with the Service.

5. Tradefair Financials shall not be liable for, and Customer agrees not to hold or seek to hold Tradefair Financials liable for, any technical problems, system failures and malfunctions, communication line failures, equipment or software failures and malfunctions, and other similar computer problems or defects.
