iv) An endorsed copy or the original of a current bank or building society statement that is less than two months old, which covers two full calendar months and which clearly states the Applicant's full name and current residential address.

v) Balances held with Building Societies will only be considered if a copy of the relevant passbook is supported by an official signed and dated confirmation of the balance from the building society in question, dated in the week that the application is submitted and which also confirms the applicant's current residential address.

vi) Endorsed copies or the originals of documentation in respect of any other investment that you hold and which can be realized as Liquid Risk Capital within 24 hours.
